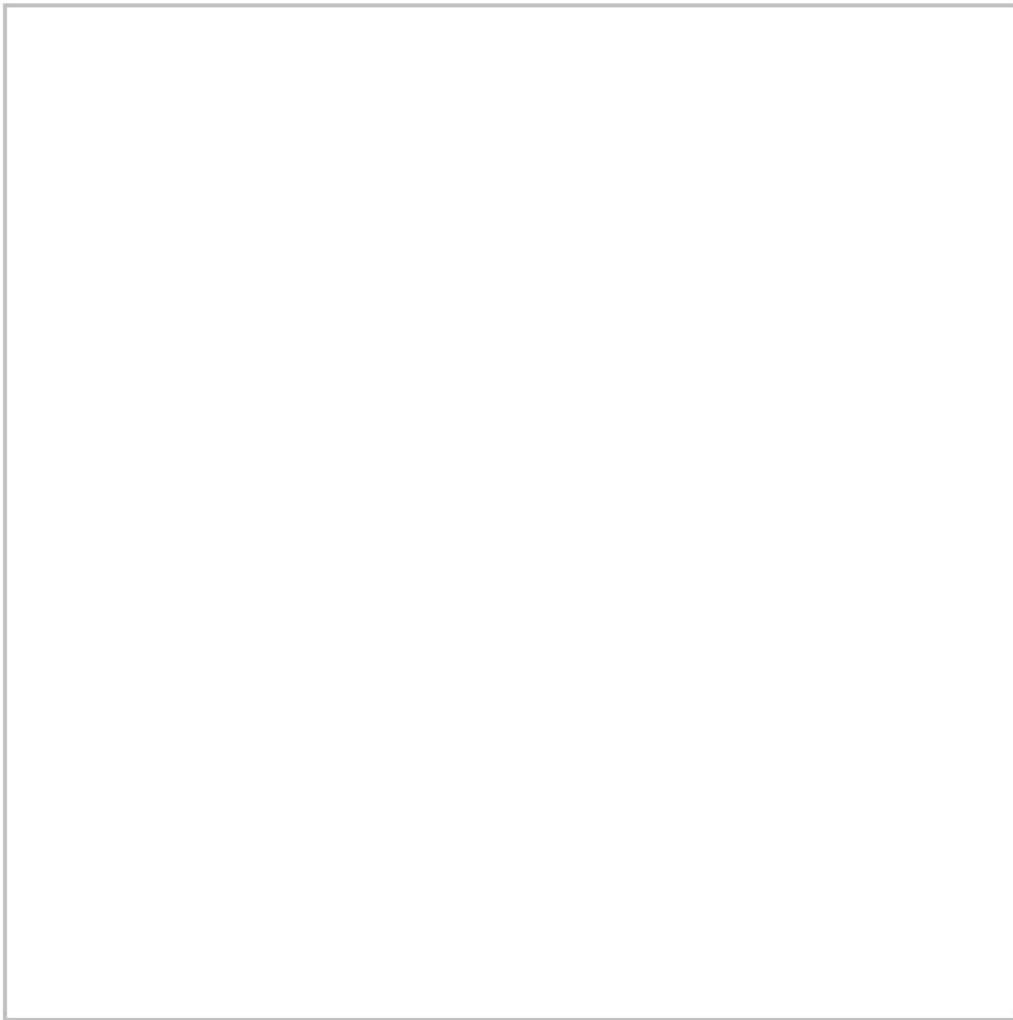

This is about standing up for the men and women of both parties, all over the country, who have dedicated themselves to facilitating democracy, in the face of a pandemic, resource shortages, record turnout, narrow margins, and threats to themselves and their families. We hope that this can be an opportunity to stand together as a community without regard to partisanship.

Matt Masterson and I are circulating the attached draft letter, documenting her competence and integrity, which we intend to send to the legislature, and are requesting you consider signing on to this letter. Mr. Becker:

Thank you for the opportunity to once again partner with the Center for Election Innovation & Research to support initiatives surrounding voter education, information, and communication to ensure safe, secure and informed elections in 2021 in the face of ongoing challenges posed by the COVID-19 pandemic. The Commonwealth of Pennsylvania (COPA) is appreciative of all grant funds received and the allowance to extend unused dollars into the 2021 election cycle. In response to the grant requirements, in total, COPA used \$13,024,512.48 of the total grant award for initiatives, of which \$205,960.52 was used during the extension period towards furthering voter education in Pennsylvania. The Department has sent a reimbursement to CEIR in the amount of \$235,487.52 on January 6, 2022, for all unused dollars.

2020 Voter Education Initiatives

- Direct Mail – Total Spend: \$4,117.29

COPA procured accessible ballot materials for the 2021 elections for county election offices. This purchase was specifically for ADA accessible return mail-in ballot envelopes. Due to the legal risks associated with relying on each county to separately procure compliant balloting materials and the volume of materials needed, it was imperative that the Commonwealth purchase the items on behalf of county election offices to ensure uniformity and minimize costs.

- Paid Media – Total Spend: \$201,283.47

COPA allocated the majority of the extended grant funds towards a paid media campaign was extremely similar to that of 2020. COPA completed a text message campaign to voters with reminders for Election Day and returning ballots by the deadline; television, radio, social and digital media (including the design and production of education material) on voting options, how to apply for a mail-in ballot, mail-in ballot returns, and assistance on how to determine a voters polling place.

Additionally, due to the process of a media buy, time blocks are procured in advance of any production of the ad. Due to the large purchase for the 2020 general election, a refund in the amount of \$215,931.48 for unused ad time was returned to the COPA after the grant extension occurred in 2021. These dollars were a large portion of the funds returned to CEIR.

- Other Communication – Total Spend: \$559.76

COPA also provided county election offices, libraries, and educational institutions with posters that could be displayed to assist voters with additional information about the recent changes in the Commonwealth's vote by mail and in-person voting procedures. These posters included information about deadlines for requesting and returning mail ballots, the process for remitting your ballot if you decide to vote in-person after receiving a ballot by mail, and the removal of "straight party" as a voting option.


