VRAV has received the following information regarding upcoming third party mailings of Vote-by-Mail applications to some voters. Below is the content of that notification.

I am writing to provide further details regarding the **vote-by-mail application mailings** that Voter Participation Center (VPC) and Center for Voter Information (CVI) will be sending out to Virginia voters starting in early August.

The vote-by-mail application mailings will be sent out in three waves, landing on approximately August 4th, August 18th, and September 8th. **Below is a city/county breakdown** detailing how many residents will receive the mailings. The largest of the three mailings will be the August 18th mailing, covering about 70% of the universe. The first and third mailings will be to smaller portions of the universe, and some voters will receive more than one mailing. **Next week we will send you proofs for the mailers based on the drafts we shared with you recently.** We will also begin undertaking a large voter registration effort in September and will send further information on that, including counts and proofs, in mid-August.

Mission: Expand Access to Democracy by Underrepresented Populations

The goal of VPC and CVI is to bring more people into our democracy. VPC and CVI successfully utilize direct mail and online formats to foster registration and voting by underrepresented populations in the American electorate. A special focus is on the New American Majority (NAM), consisting of young people, communities of color, and unmarried women.
